**ORDER U/S 12AA OF INCOME TAX ACT, 1961.**

"Entrepreneurship Training and Rural Development Initiatives (ETRDI), H.No. 1504/2, W.No. 5, Ranjit Nagar, Kharar, Distt. Mohali." registered on 22.07.2004 under the Societies Registration Act ( Act XXI of 1860), has applied for registration u/s 12A(a) of the Income-tax Act in Form No. 10A on 31.05.2007. The application made by the society is beyond the prescribed time, as it was required to be made within one year from its date of registration i.e. upto 21.07.2005. The reason for delay in making application has been explained that the members of the society were not aware of the provisions of the I.T.Act. The explanation given by the applicant has no force in it and is not acceptable, as it has duly been complying with the other provisions of the Act like audit of accounts from Chartered Accountant.

2. However, since the society is engaged in charitable activities, it is registered as Public Charitable Trust u/s 12AA and in view of the proviso (ii) to Sec. 12A(a) of the Act and registration is allowed w.e.f. 1.4.2007. The application has been entered at S.No. 190-E in the register of application u/s 12A(a) maintained in this office.

3. The return of income shall be regularly filed by the society within the prescribed time as per provisions of sub-section (4A) of Section 139 of the Income Tax Act, 1961.

4. It is clarified that this certificate does not entitle the applicant automatically to the exemption of its income u/s 11 and 12 of the Act. The Assessing Officer shall be free to decide such claim of exemption of income of the society u/s 11 and 12 after examining it on merits and after satisfying himself that the conditions and requirements laid down in these sections are fulfilled by the Society.
